NCIDQ Exam Reference Materials

Most of the content of the NCIDQ Exam comes from a common body of knowledge that is generic to the practice of interior design. Having well-rounded professional practice is your best preparation for the exam. However, you are encouraged to supplement your education and experience by reviewing interior design resources, particularly those that focus on areas where you are less skilled or experienced.

The materials listed here can help supplement your understanding. This list does not represent the entire body of information you can use as study material. It is a representative list of references used in the CIDQ exam development process. While the list may include more than one reference that covers a content area, one such reference may be enough. Other resources that are not on the list may adequately cover the content area as well.
